The 4 hour time frame includes set up and breakdown. After a four (4) hour rental a \$100 per hour fee is charged. This fee does not include the fees for technical personnel. All estimated rental costs are due 14 working days before the performance date. Payment must be in the form of bankcheck or money order. Non-payment will result in cancellation of the performance without notification. A performance rental is limited to four (4) hours.  Submit application, documents, and checks to: <b>Carrollton Center for the Arts, 251 Alabama Street, Carrollton, GA 30117.</b>  The Amphitheater at Adamson Square is an outdoor open-air facility used for musical events, movies, and concerts. The seating capacity is between 500 and 750 on a tiered lawn setting. If the requested date is available and approved, <b>a \$250 non-refundable deposit is required to hold your date.</b> The deposit will be applied to the remaining rental fee.  <b>Make checks payable to: The City of Carrollton</b> <b>Credit Card payments must be made at the City Hall Water Department (Visa and Mastercard only).</b>		
<b>Cancellations /Refunds:</b>	Cancellations must be made in writing at least 14 days prior to your event. The \$250.00 deposit is nonrefundable. Cancellations made less than 14 days will forfeit entire rental amount of \$400
